This will be our second annual Snow Spectacular event. Last year we had over 3,000 people attend this event. We will be bringing in over 100,000 pounds of snow for snow slides, snow play area and a picture in snow with Santa. We are looking for vendors for this event especially vendors that are selling Christmas/Holiday themed items.

Invoicing will begin December 1st for approved applicants. The rate will be \$50. This fee is per company. We do not allow more than one company per spot. The vendor application fee is non-refundable.

### **Important things to note:**

**\*\*\*Please if you sell Paparazzi, Scentsy, Lip sense (etc.) put that as your company name.\*\*\***

**\*\*\*We reserve the right to ask anyone to leave for any reason.\*\*\***

1. The vendor fee covers a 10'x10' empty space on the street with no power and we do not allow noisy generators. Additional space cannot be guaranteed unless you purchase an additional spot. Utilities, equipment, tables, etc. are NOT provided.
2. Please only submit the form ONCE unless you want to be billed for multiple spots.
3. The fee is non-refundable. If there is significant, bad weather the event will be rescheduled, cancelled or vendors will be moved inside.
4. We want you to have a successful event. For this reason, we do not accept duplicate vendors. For example, we will not allow more than one Scentsy vendor, etc. Any duplicate vendors who attend the event will be asked to leave.
5. **\*\*If you are selected as a vendor\*\*** you will receive an invoice.
- 6) All participants must stay for the entire event.
- 7) Set up starts at 6 am. All vendors must be set up no later than 9 am, food trucks included. Also, any vehicles must be parked outside of the event area at this time.
- 8) **PAYMENT:** You are not guaranteed a spot until you have paid. Payment must be made by the due date invoice. If payment has not been received, your entry will be deleted and you will have to submit a new form.
